## **Chairperson's Report to the April 4, 2007 Area Service Committee of SacFNA**

### **Debriefing Last Month's ASC:**

I thought last month was a splendid first try at consensus decision making (CDM). Good for us! It really seemed like we were hearing each other's concerns and allowing those concerns to shape our decisions. It was great to hear from so many in the room – not just the quickest thinkers or most articulate speakers. With the CDM model, we listen to each other's ideas because we know our own ideas will also be heard. Conflict is not something to be fixed or stifled, but something to be understood and addressed. It's a beautiful thing and we'll get even better at it with practice.

### **Update on Our Website <sacfna.org>:**

Bill L. from the Elk Grove Home Group generously established our web presence as we worked on guidelines and planned for what's now the Sacramento Fellowship. He has continued to serve us in the capacity of "webservant" and has kept the site up-to-date as we made our name official and changed the location of our meeting. He's also uploaded documents, like our agenda packet, in order to keep interested members informed and our work transparent.

Our guidelines state that minutes from each ASC meeting should be posted to our website within 10 days of each meeting and that the agenda packet including all reports be posted to the web at least 3 days prior to each ASC meeting. While the website currently serves this function, it could easily begin to look like the door to my refrigerator (plastered with fliers, coupons, and drawings). Since our website may be the first point of contact for the still suffering addict or community member, Bill and I talked about redesigning our site to make it more welcoming and easier to navigate.

Bill's experience working on the websites from other Areas and our Regional website is a real asset. He cautioned against developing something so fancy that it would take someone with real technical expertise to keep it updated. With this in mind, I developed a mock up of a 5-page site and seek your consent to have Bill proceed in its creation.

### **Schedule:**

On a related issue, I've heard some of you express a desire for a schedule. Online, it's simple to provide our schedule while offering access to meetings in other Areas with links. Since many website visitors might want to download and print a schedule, I developed a printable schedule for the purpose of our website.

This could certainly be printed and distributed if you wish. Before we do so, we need to carefully consider what the consequence might be. Keeping in mind that, so far, the ARANA schedule still lists our meetings, do we want/need a separate schedule? If so, why? How does this decision (for or against) serve the best interest of the newcomer? Should we hold off on taking this action in hopes of negotiating a joint schedule with ARANA and perhaps other surrounding Areas? Let's talk about this, pray about this, and talk about it some more.

### **GSR Reports**

I hope sharing the ideals we believe contribute to building strong home groups went well a few moments ago. If so, I hope you'll give some thought to the practices you have in place which contribute to your group's strength and vitality and prepare to share about that next month. Again, here's some food for thought on this topic:

#### **PRACTICES: How strong home groups operate, such as:**

- Safe and Positive Environment – Our format keeps us focused on recovery.
- Teaching Principles – The group discusses the steps, traditions, and literature.
- Self-Support – Members give time and resources freely to support the message.
- Good Public Relations – Our group reflects well on NA as a whole.
- Encourage Diversity – The meeting reaches all newcomers and welcomes them home.
- Nurture All Members – Group members are supportive and challenge each other to grow.

D. Policy on Literature Payments

**Proposal I: Just money orders**

- Shouldn't take personal checks at all. We should only accept money orders.
- Work only with secured money orders
- Money orders are replaceable if lost
- Group doesn't have a lot of money and can't buy money orders. Why give \$1.50 to outside entity?
- 26 groups, 96 cents each, equals \$144 per year for money orders.
- There are cheaper places to buy money orders.

**Proposal II: Personal Checks Okay**

- GSRs may have limitations.
- A check for \$24 could bounce as easily as one for \$26. \$40 check limit is reasonable.
- Checks can bounce. We pay a fee for bounced checks. It's the GSRs decision.
- No cash for group donations. Bounced checks really impact our finances. Maybe we can raise the limit at a later date.

**Proposal III: Money Order Preferred but Cash Accepted**

- No cash, less temptation.
- Someone gave a bag of coins last month. Some volunteers may have very little clean time.
- RE: temptation. We entrust folks all the time with money in a variety of situations.
