* Note: In reviewing the minutes of our last ASC meeting, your admin team identified a number of decisions and/or actions that seemed to be of interest to the group. In order to streamline our process, we shaped these into draft proposals for further consideration. Remember that with consensus decision making, debate is not limited to “for or against” any proposal; these are just starting points that can be altered to suit your needs and address your concerns or rejected entirely. Every decision we make here belongs to our entire service body.

Chairperson's Report to the May 2, 2007 Area Service Committee of SacFNA

Debriefing Last Month's ASC

I thought last month's poster session and the discussion that followed were very productive in helping us establish priorities and formulate next steps. If I understand you correctly, you'd like to see us both...

- work with ARANA to determine the best way to coordinate our efforts and/or share some services, contributing a fair share of the necessary human and capital resources required *AND*
- get some activities and services up and running on our own as soon as possible

Dave M. delivered our request to the American River ASC regarding continued support with the phonelines and schedule. Since it was their inventory night, no motions were considered, however it is likely that motions regarding this and other issues of interest to our Area will be considered at their next ASC. Thus far, it's been business as usual, so we may wish to consider making a donation to American River to contribute towards these continued services.

Given the emerging consensus for dialog between the two Areas expressed at our last meeting, Carlos and I extended an invitation to AR's admin team to meet jointly with our Admin team in order to open lines of communication. Although we have not heard back from them, I understand that the possibility of a joint meeting was also discussed at AR's admin meeting and that they are hesitant to act without the express direction to do so from their ASC. The possibility of an admin motion suggesting the same was ruled out of order, so direction will need to come from one of their GSRs in the form of a motion.

Although many decisions about our services and service structure are on hold for now, there are many areas in which we can move forward without further delay. In reviewing the minutes from our last meeting, your admin team identified interest in providing some outreach services, activities, learning days, an expanded schedule, and liaisons to standing subcommittees in AR -- all of which we can begin working towards tonight if you wish. In order to streamline our process, we're putting these on the table in the form of proposals; consider them half-formed lumps of clay that we can shape through discussion.

Establishing a Service Structure

Last Saturday, I attended a workshop put on by the Greater San Jose Area to reconsider their service structure. To summarize, they are reconsidering the wisdom continuing to use the subcommittee structure, which many view as outdated and an inefficient use of human resources. As a result of examining their current structure and two models proposed in Chapter 3 of the new Public Relations Handbook (available at: http://www.na.org/handbooks/PRHB_Final_24Oct06.pdf) the group of 49 in attendance decided to ask their ASC's approval to form a Working Group to develop plans to transition to a new model.

This seems to be a time of creativity and innovation in Narcotics Anonymous. While our primary purpose remains the same and accountability is still critical, it's very exciting that we can have the flexibility to experiment since we're not tied down to a particular model. Since we'll need to address the question of service structure shortly, you may wish to propose a similar workshop to examine various models if that's of interest.

GSR Reports

Tonight we'll be sharing the practices of strong home groups. Next month, we're slated to discuss the way our groups and members interact within NA and with the community at large. Here's some food for thought on the topic:

How does your group interact with NA and the community?

- Evolves with Members – Members' personal growth strengthens the group.
- Establishes a Network – Our group puts newcomers in touch with experienced members.
- Gateway to Service – Members introduce newcomers into group service, then beyond.
- Model of Service – Our group prepares trusted servants to work well at other levels.
- Unity and Credibility – We work with other groups and ASC in a spirit of cooperation.
- Positive Message – Group members are an example of NA changing lives for the better.

Senior RCM Report

I attended the April 14, 2007, Regional Meeting and returned with some flyers of the May events being hosted by some of the areas (see table) I also brought meeting schedules from other areas.

I have a copy of the reports given by our Regional Committee RD and Alternate RD if anyone is interested. (The reports are on the table as well.) There is some pretty good information on the Florida Service Symposium- Questions asked such as "Who is missing from our meetings?," Youth IP workshop, our service system, and Area Planning Tool Strategic Planning. Also reported was a workshop on "How to be a more effective RCM," The Florida Symposium discussed the difficulty RCM's often face in trying to communicate the complex discussions happening at World Services and the Regional Services Committees under the constraints of brief reports at their ASCs. The evolution of our service structure in the last few years from one of motions to one of open forums, issue discussion, consensus, has made concise reporting more difficult. In the old days, reporting from the WSC or the RSC was simply a matter of listing which motions passed or failed. Today, very little occurs in the business sessions and the real value of what we do is often found in the sharing. Yet, finding a way to condense these discussions and avoid reporting that sounds like an endless stream of data to an often impatient ASC can be very difficult (Does this sound familiar?)

While they identified several important characteristics and criteria for an effective RCM, it seems that "knowing the values, culture and beliefs of your area" were most important. Intimate familiarity with your area is the best guide post on deciding which items to emphasize in your reporting. We all agreed that there is no easy answer or single "one-size-fits-all" template for reporting the information RCMs have been entrusted to convey.

"Knowing the expectations of you in your job; your responsibilities to provide leadership, the degree of delegated authority you have" were identified as the other top criteria in being an effective RCM. It was felt that, even more important than knowing area guidelines & policy, it is important that you understand the degree of leadership and delegated authority you have in your reporting and interactions with the ASC, groups, subcommittees and the RSC.

This was the first NAWS workshop on this topic, ever. A lot more will be revealed!

I had a chance to talk to the ARANA RCM and Alt. RCM and asked if ARANA Admin and SacFNA Admin could sit down and talk and formally open up lines of communication and bring up the topic of some shared services such as meeting schedules, phone line, etc. We both agreed we should invite our RDs and ask them to help facilitate the discussions with our chairs. I then forwarded an email to their Admin but have had no response yet. I hope if and when this communication begins that you grant us the ability to make some decisions on your behalf and have a high level of trust that we will do what is in the best interest of NA as a whole.

Junior RCM Report May 2007

On April 14, 2007 both Carlos and I attended the Regional Service Committee. This is our combined reports.

During Area Reports the American River Area donated \$2400 (these dollar figures are rounded off). Their RCM raised a question that was later discussed in Area Forum about whether members in "both" areas could do service in ARANA...more later. Contra Costa Co.'s Unity Day will be August 18th at the CoCoCounty Fairgrounds. They also have a monthly speaker meeting and dance. The RCMs of both East Bay Central and East Bay North had reports with nothing of particular interest to this area. Greater San Jose donated \$1831. and elected all new admin and sub-committee chairs. Humboldt-Del Norte will have their Unity Weekend Aug. 17-19 at Richardson Grove. Lake County will have a Cinco de Mayo Dance on May 12 at the Clear Lake Masonic Lodge. Marin donated \$150. Mission Peak donated \$1600 and announced that the Tri Area voted to make theirs a Metro System. Napa-Solano donated \$139. Their ASC is holding on to a large sum of money, over \$8000 over their prudent reserve. 916 North donated approximately \$1420. Their Unity Day will be on June 23 in Corning. Peninsula donated \$188. River Cities will hold their Men's Retreat on Sept. 16 at Whiskeytown Lake. Santa Cruz reported a large profit from the MBCNA with \$45431 in income and \$29819 currently in the bank. There will be a sizable donation when the books clear. Sierra Foothills Unity Day is May 5. Sonoma donated \$1861.

As stated one of the topics in Area Forum was whether members should be able to do service in more than one area. The consensus was that there was no problem with this, that individual addicts can do service where ever they feel their talents and experience might be best utilized. The second topic had to do with coordination of Phonelines and schedules and how to keep them current.

The alternate Regional Delegate gave a report that lasted over an hour and was 9 pages written. It covered a variety of topics from the Florida Service Symposium. While interesting, my report cannot begin to cover what was reported. If you are interested, come see me and you may read the report.

NCCNA 29 was a huge success. The accounting is not in but judging solely by merchandise sales there should be a large profit. Of nearly \$50,000 in merchandise bought less than \$1000 was left at the end of the convention. Registrations were down a bit but this shouldn't impact the profit by much. There are still seats on NCCNA 30. If you are interested, people are qualified and voted on at 5:00 at the RSC.

We brought flyers and schedules back for you. There are very few of these available so you might want to write the information down to take back to your groups.

Member confused about what the problem is. Why are we concerned about shared services? Aren't we all in the same Fellowship? Serving the newcomer?

Where do we stand on shared services? Where does ARANA stand on shared services? What is best for the addict who still suffers?

We're concerned about financial responsibility. Are we expecting ARANA to cover the cost for shared services? We are currently covered on phone line, schedule, etc. Let's consider maybe expanding the schedule. Need to dialogue with ARANA re: these issues.

We need to stand on our own at some point. We can't wait for ARANA to accept us, we need to be proactive and start communicating, go to their ASC and liaison with them, build consensus. We contribute to ARANA financially and in human resources in past and currently.

Need to make a proposal to ask ARANA to keep us on schedule and phonenumber and offer to pay our share of costs. Ask to add our name to the front of their schedule as well. This will begin a cooperative movement. Most ARANA GSRs want this new area to be a success.

How are we going to do H&I? How about the H&I can money? What about PI? How long before we stand on our own two feet?

Newcomer is the most important person in the meeting. Would it be a good idea to form a subcommittee to investigate/resolve this specific issue? Especially as it involves how to communicate with ARANA.

Vision for the phone line is a live body on the other end of the line.

V. Decision Session to Consider Proposals

Proposal I. Propose to have a representative of SacFNA go to the ARANA ASC on 4/13/07 and ask if they are willing to keep our meetings in their area schedule and on their Phonenumber and that we offer to pay our pro-rated share of these services. - Aggressive PR committee
- Use recycled paper, \$ less (more paper)
- Increase awareness in groups, H & I, community that pamphlets are available online
- Dare to put an ad out in the streets like bus stop or billboards. That's where the drugs + users are
- Put NA meeting schedules or stickers w/ phone # @ light rail & bus stops & Walmarts

Relations with recovery houses, parole/probation, drug court

- More meetings w/ a variety of times
- Get people who want to be involved! Sponsor to open doors for those still suffering
- More Public Service Announcements (PSAs)
- Aggressive interaction with community services
- Committee formed specifically to visit recovery houses for q&a and NA orientation
- Bring meetings into the residential treatment facilities or book studies to help newcomers understand sponsorship & steps (newcomers often confused about the process of getting sponsor)
- Tell law enforcement agencies about NA & how it changes lives
- Speak in high schools to those yet potentials or already in active addiction

Legitimate fears/paranoid fantasies

- Don't stifle by time constraints
- SacFNA is out to ruin ARANA
- ARANA is out to ruin SacFNA
- By attraction, we may grow to large – back up plan for limitation number and new split off
- SacFNA will be too small to provide dances, speaker meetings, fundraisers, etc.
- Change is uncomfortable
- Oh No!!! What will others say about me or my home group
