Good evening. My report will be brief this month. I did not go to the Regional Service Committee meeting in May due to the Woman-to-Woman Celebration that took place the same day. While I am committed to my service work, I feel it is important to also support events put on by groups within our area.

I attended the Public Information Sub-committee of the American River Area as a liaison from SacFNA. The membership of the PI sub-committee was welcoming and for the most part appreciated our area's reaching out.

I have done some research into this area putting on a learning day. The Regional guidelines for putting an event and receiving funding require that a budget and date for the event be submitted at least six months in advance of the event. The annual budget period for these events begins in July and seed money is provided on a first come, first served basis. ### "A.S.S.N.A" Pure Spirit Traditionalist Gathering:

My (RD Delegate Alt.) Florida report last month referenced the fact that there are a handful of long-time members on the East Coast that remain very bitter and resentful towards NA World Services to this day for perceived slights, mistakes or mis-steps that had occurred in the eighties and early nineties. These members are holding a "Pure Spirit Traditionalist Gathering" (a campout) in Hamburg, PA on June 22-24. Amongst their topics will be creating a new or alternative service structure that they view as directly responsive to NA Groups. Of course, some assuredly biased History and Traditions workshops are on the bill as well. These members also use the moniker "A.S.I.S.N.A" or "Alternative Service Informational Structure" and advocate the boycotting of NAWS and the use of their own literature.

### Fellowship Development

As I (RD Alt.) reported to you last month, In addition to staffing the Worldwide Workshop in Nebraska, a NAWS travel team is attending the second Middle East Workshop in Bahrain. The first was put together n=by NAWS in 2005 and the promise was to do another in 2 years. Bahrain is the location because this is the only Mid East location that the Iranians are allowed to travel into. The first clean Muslim woman in the gulf, a member from Saudi Arabia who happens to be eighteen years old, is celebrating one year clean at the workshop!

In closing my report I may not be at the September 5 ASC meeting due to an extended stay in San Antonio.
