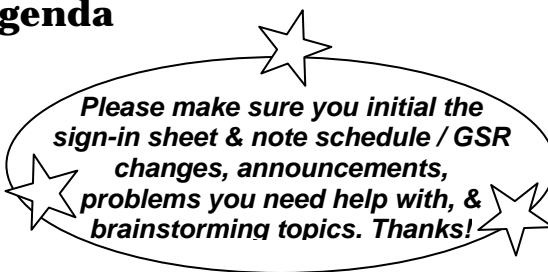

## **Chairperson's Report to the August 1, 2007 Area Service Committee of SacFNA**

### **Sign-in Sheet**

There's a sign-in/update sheet circulating on a clipboard. Please initial to indicate your attendance this month and note any schedule or GSR changes, announcements, problems you'd like help with, and/or topics you'd like to hear discussed in our brainstorming session. This is an experiment to streamline some of our housekeeping processes so that we have more time for discussion. We'll see how it works!

### **Learning More about Consensus Decision Making**

Like many things in life and recovery, learning about consensus decision making (CDM) is a process not an event! Tonight, we have 3 opportunities to gain additional knowledge about CDM:

1. I've cut and pasted the table on the next page into my report. It's a good reminder about our process for shaping proposals through discussion. It's all too tempting to fall into the old "for or against" mindset; this restaurant scenario reminds us that the point is to hear each other and be open minded about creative solutions. I hope you'll read it at your leisure.
2. I've passed out colored cards to see if they help us facilitate the consensus process. As the directions indicate, each color has one meaning during preliminary discussions and another during consensus decision making. It's an experiment.
3. Finally, I've listed "Discussion Guidelines for Consensus Decision Making" as one of the topics for our Brainstorming Session. I hope we can generate a list of standard practices that will keep our discussions lively, productive, and respectful.

### **Guidelines Revisions**

We spent the bulk of time in this month's admin meeting (the 3<sup>rd</sup> Wednesday of each month, 7-9 pm, here...join us!) amending the guidelines. You should each have a copy that shows all the changes proposed, the bulk of which relate to using CDM instead of Robert's Rules. If you have specific concerns about any portion, perhaps you can suggest we discuss these in our brainstorming session. It would be good to raise your concerns now so we can make any additional changes you'd like and be clear on the issues when you return to your groups. Next month, we'll make a decision about adopting these guidelines.

## Some Examples of Cooperative Decision Making

*Eight people want to go out to dinner together and are trying to decide on a restaurant...*

Decision Process	Description	Comments
<b>Unanimity</b>	Everyone's first choice happens to be a Mexican restaurant.	Nice if it works out that way and quick to decide, but doesn't happen very often.
<b>Convincing Argument</b>	One person likes a French restaurant — after describing it, everyone is convinced that this option is better than their original preference.	Sometimes works but frequently doesn't.
<b>Follow a Popular Leader</b>	One person wants to go to a German restaurant — everyone else wants to do whatever that person wants more than they want their own food preference; or they believe that that person knows better what is best for the group than they do.	Easy to make decisions this way, but often based on people's low self-esteem or cultish devotion to a leader
<b>Compromise</b>	Some want to go to a Vietnamese restaurant, some want to go to a seafood restaurant, and some want to go to McDonalds so they decide to go to the seafood restaurant this time, the Vietnamese restaurant next time, and to McDonalds after that; or they decide to go to another Vietnamese restaurant that serves Vietnamese dishes, seafood, and hamburgers, but none of the food is very good.	Nobody gets exactly what they want, but everyone gets part of what they want and everyone is treated fairly.
<b>Implicit Majority</b>	If 5 people want to go to the Vietnamese restaurant, 2 want to go to the seafood restaurant, and 1 wants to go to McDonalds, they could decide to go the Vietnamese restaurant since that is what most people want — the others agree that they do not want to get in the way of what most people want. Without a formal vote, the group goes with the majority.	Usually satisfies most people, but the minority may feel ripped off, especially if they must defer too many times.
<b>Intensity of Preferences</b>	Maybe the 5 who want Vietnamese food are mostly interested in eating unusual food, the 2 who want seafood don't like spicy food, and the person who wants to go to McDonalds cannot afford to spend more than \$3. Here the people who don't like spicy food have a stronger reason not to go to a Vietnamese restaurant than the people who like unusual food have a reason to go so it takes precedence; but the person who wants to go to McDonalds absolutely cannot go to the other more expensive places, whereas everyone else can go to McDonalds — so they decide to go to McDonalds.	A type of least-common-denominator process that is often not very satisfying.
<b>Meeting Everyone's Needs ("True Consensus")</b>	They decide to go to a Japanese restaurant (unusual, but not spicy) and everyone chips in to cover the cost for the poor person.	<ul style="list-style-type: none"> <li>• Everyone's true needs are met and a solution is found that everyone feels excited about.</li> <li>• Not a compromise or amalgam of people's original preferences, but a "third way."</li> </ul>

- People trying to use consensus, use all of these processes
- The last option is probably the best and is usually thought of as closest to the spirit of consensus — a "true consensus"
- Notice that each of these solutions could have been reached cooperatively (everyone truly agrees that the solution is best), through coercion (people reluctantly go along with the decision only because they are intimidated or mesmerized), or through exhaustion (people go along because they are tired or they don't know how to come up with a better solution) — *consensus is the spirit, not just the process*
- All are fine as long as they are cooperative, but strive for the last one

**SacFNA Vice-Chair Report**  
**8-1-07**

I participated in our review of our guidelines during the admin meeting. It was mentioned at our last ASC that tonight we were going to review and finalize the guidelines. I feel confident that we have a good framework on which to establish our Area and move forward with fulfilling our primary purpose, providing services to the Groups in the SacFNA Area.

As of when I am preparing this report, the second meeting between ARASC and SacFNA concerning H&I, PI, Phone lines and sharing these services has not occurred. But as stated last month, the Ad-hoc committee felt that sharing these services between our two areas was the best way to move forward. It's possible that this position will be presented at the ARASC meeting this coming Friday.

Along this line, we should prepare ourselves for what providing our share of funds for these services. My recollection is that the monthly budget for H&I is approximately \$1,400. If there are 150 meetings between American River and Sac Fellowship, and we have 35 meetings, then we have 23% of the meetings in the area. 23% of the \$1,400 monthly budget from H&I is \$322. These are rough numbers. Our share may be less, or it may be more. We have to take into account funds H&I receive from groups in the American River area from their H&I cans. More than likely we need to calculate the amount ARASC gives H&I to cover their budget beyond what H&I get from the groups. Either way, we're going to have a significant H&I expense in the coming months.

At our last meeting, we had some intense discussions concerning groups that pass the H&I can. I would like to suggest to those groups that they discuss at their business meetings donating their H&I collections to the Sac Fellowship so that we can pass those funds onto H&I. In the end, the money from their H&I cans end up in the same place; the American River H&I committee. But this way, Sac Fellowship would add to their funds to total whatever the share of the H&I budget we are asked to provide.

I hope also that groups discussed at their business meetings the discussion we had last month about activities and how we can move forward with starting the planning process for future activities. Maybe some sort of Saturday holiday potluck speaker meeting could be planned. Remember, it's best to think at least 90 days out in order to get seed money set aside by our Treasurer, get the committee going, plan the event, find a suitable location, print flyers etc.

They are considering sharing some lists of members who may be willing to fill in some Prison Fire Camps that need help so the meetings don't go dark.

The Region meeting went well with some people asking if we received prior permission to include meetings outside of our Area in our schedule. I responded I didn't know but that I didn't think we should have to ask permission since we are all one fellowship. Many other RCMs liked the idea of a regional schedule and took a Meeting Book to show their Areas and maybe consider one of their own.

NCCNA reported a \$98,000.00 profit after all the receipts were collected for the 2007 Convention.

We put off responding to our June Regional Inventory Workshop until September and anyone interested is welcome to sit in and participate. (2nd Sat. in Sept. 1:00 P.M.) In Ann's report last month you can review the topics we will be discussing and wanting to maybe change. Number one on the list is No Robert's Rules of Order.

I attended the Admin meeting and helped out with the Guidelines Review.

**IV. Deliberation Session** (brainstorming/open forum)

- Men's Campout in September 7-9, 2007, only 150 spots available. Going fast.
- Vice Chair of ARANA Softball Tourney, August 11. Starts at 8am. Need scorekeepers, folks to help with food and other stuff. Rusch Park, Antelope and East 80. Go to SacramentoNA.org website for more information.
- RE: Support. It's the responsibility of each group to stand on its own feet. Groups should take care of themselves. Groups shouldn't advertise for treasures and GSRs at Area level.
- RE: H&I can: Concept 11 addresses the issue of donating to subcommittees.
- RE: Support: Moving the location of a meeting may be all that is needed to resolve an attendance issue.

- RE: Support: Support is about getting people to do whatever is necessary to get the meeting to happen. Setting up, if you continuously have to go outside the group to get warm bodies to hold the meeting together the quality of the message will suffer.
- This building is being torn down in 2008. Our group uses this building and is grateful to be here.

## V. Decision Session

**Proposal 1:** To adopt guidelines and procedures for activities hosted by groups and coordinated in cooperation with SacFNA-ASC.

- The single point of accountability is a group.
- It would be a good idea to put a committee together to plan these events.
- Why are we entertaining the idea of groups putting on events when we have a service structure that calls for subcommittees that allow groups to do recovery meetings and subcommittees to take care of the activities?
- We need to think about the services we want to give and the best way to give those services. Whether they are standing services or they are flexible with people floating in to serve at different times.
- Go to Regional assembly and they will be talking about that.
- Group is concerned about taking away from primary purpose. Think it is Area's responsibility.
- Concern about the money. Concern about ASC motives. Meetings should provide own funding and be self-sufficient without ASC funds.
- This is no different than the broader group doing an annual picnic. We're only providing a way for groups to come to Area to ask for money.
- What happened to the lists of people volunteering to be of service? Many have been collected.
- How do we form an event committee? Propose an event and a coordinator.
- Would we post activities on our Website? Yes.
- Example: Circle of Sisters, independent group. Held in an Area and supported by Region and Area.

*Consensus was not gained on this proposal. Proposal was put off for one month.*

**Proposal 2:** To buy a coffee pot and identify a coffee person and place a donation cup by the coffee table. We will buy the coffee pot for \$100.

Many thumbs up for the coffee pot. ASC would buy coffee cups, cream sugar, cups, etc. Have a basket by the coffee pot to help fund the cost..

- Not a prudent use of our money. Will our 7<sup>th</sup> tradition go towards purchase of coffee and supplies?
- Good idea because it will provide a welcoming feeling.
- How much will it cost (estimate)?
