Chairperson's Report to the September 5, 2007 Area Service Committee of SacFNA

Our experiments continues...

Sign-in Sheet: Signing-in on the clipboard and giving updates and announcements in writing seemed to help the flow of quorum call & group reports last month, so we're trying it again. Please be sure the clipboard gets around -- initial to indicate your attendance, note any schedule or GSR changes, announcements, problems you'd like help with, and/or topics you'd like to hear discussed in our brainstorming session. All of this information will then be projected as we you give a verbal report.

Color-coded Consensus Decision Making

We'll also continue to experiment with colored cards to facilitate discussion and decision making. I'm finding it helpful to think of them like a traffic signal with orange being a shade between red and yellow. Anyone in the room can participate in discussion, so there are more card sets on the back table if anyone needs them. When we come to the moment of consensus, however, only one representative from each group should register their agreement or dissent. In other words, if you're an admin member, a visitor, or an alternate GSR attending along with the GSR for your group, please allow your group's conscience to be registered just once.

Public Relations

Dolores, Ann, & I attended the PR training offered at the Nor Cal Regional Service Office last month. The River Cities Area seems to be furthest along in applying the concept of a "PR umbrella" that's described in the new Public Relations Handbook (available at: http://www.na.org/handbooks/PRHB_Final_24Oct06.pdf). The key idea is that in order to achieve our vision of "recognition and respect for Narcotics Anonymous as a viable program of recovery" it's helpful to think about the needs of whole communities instead of considering hospitals and institutions separately from the rest. As we carry our message to community events or locked-down facilities, we want to demonstrate the unity and cooperation of our program in action. The classic and often described problem of the old subcommittee model is that when the Public Information folks (who tend to clean up pretty good) show up to meet with officials in ties, then the H & I volunteers show up to do a meeting with Harley t-shirts and full-sleeve tattoos, it makes us appear a little schizophrenic. It's hoped that the increased coordination of these two functions (PI and H&I) would provide a more cohesive approach and improve our relations with outside entities.

Meeting w/ARANA on Sharing Services

A third meeting regarding coordinated and/or shared services between our Area and the American River Area was cancelled due to poor attendance on the part of ARANA admin. The motion that formed this committee specified that at least 2 members from each admin team (SacFNA's and ARANA's) attend. No AR admin members showed up, so the meeting was cancelled.

Sac & Surrounding Schedules

The second printing of our schedule booklet is available tonight. After selling them at Sierra Foothill's ASC and at the regional meeting, the remaining "Summer 2007" schedules were purchased at cost by a few members (allowing us to break even) and donated for distribution through American River's Hospitals & Institution Subcommittee. The updated "Fall 2007" Sacramento & Surrounding Communities Schedules are available here for 75¢ each and can be downloaded from our website for free.

RCM Report September 2007

Good evening. Both Carlos and I attended the Regional Service Committee in August. I presented the Sacramento Fellowship's report.

There were four topics discussed during Area Forum last month. These topics were as follows:

1. East Bay Central; Requested to hear what other area's H&I committees are doing as far as men going into women's facilities and vice versa.
2. East Bay North; How to get meeting attendance at Area.
3. Marin; Concern about "Narcotics Anonymous" being on flyers rather than the NA symbol.
4. Marin; Asking for letters of reference from successful relationships with facilities, writing thank you notes, giving gifts.

Area Forum allows for the open discussion of topics that an area has concerns or questions about. There is generally a consensus of ideas that the RCM can then take back to their area.

The Regional Delegate has requested that ASC's consider hosting a Conference Agenda Report Assembly (CAR) in 2008. I believe that the SacFNA should consider this; it would help build unity between our area and other nearby areas. In order to make this a viable option, the RSC has the following guidelines:

The RSC will pay all expenses that are in accordance the guidelines:

Budget:

1. Each zone may spend a maximum of \$500 for their bi-annual CAR assemblies.
 - a. The total RSC cost annually will be a maximum of \$2500.
2. Budgeted cost includes Facility cost and fliers for all meetings within the zone.
3. The fliers must be distributed 2 months prior to the assembly
 - a. The number of fliers will be determined by the number of meetings and/or groups within the zone.
4. Copies of all pertinent information, needed for the assemblies will be provided by the RSC, at additional cost, above the \$2500 budgeted for the assemblies.
 - a. The content of this information will be determined by the RD and RDA, and will be consistent at all assemblies.
 - b. Copies of the Conference Agenda Report will be made available for sale and loan at each assembly

Host Area RCM

1. Coordinates with the RDA to arrange the dates and location of the CAR assemblies within their zone.
2. Distributes fliers to all areas within the zone 2 months prior to the assembly.
3. Works with the host area or areas within the zone to put on an event, if the area desires, in conjunction with the CAR assembly.
 - a. Financially supported by the area or areas involved.
4. Performs misc. tasks as needed.

I believe that we can accomplish a CAR Assembly within the budgetary guidelines and Host requirements. I hope we can discuss this during proposals.

NCCNA XXIX finally closed their books. The Convention donated in excess of \$98,000 to the RSC. Any amount over the RSC financial requirements will be passed on to the WSC.

Question: Does the concept discuss the right to vote or right to express one’s conscience?

Response: Concept addresses full participation.

Response: Concepts 2 and 7. Now is the time to interpret the concepts – consider how they apply to this particular topic.

Question: Are we talking about elections only or about proposals?

Response: Current guidelines state in Article 1, Section B, admin votes in case of a tie. Currently, the ASC only takes votes during elections.
