Chairperson's Report to the November 7, 2007 Area Service Committee of SacFNA

Can I tell you how excited I am about the Spaghetti Dinner next Saturday? Mama Mia! Hope to see you there.

Location, location, location

As you may recall, this community center is slated for a major renovation next year so will be closing at the end of December. I have identified the following options:

1. 2791 24TH Street @ 4th Ave (Sierra 2) - 84'x29' = 2436 sq.ft. - \$120/ASC meeting
2. 2900 Mather Field at Folsom Blvd (Mills Station - Cordova Recreation & Park District) 24' X 50' = 1200 square feet + kitchen

I'm still waiting to hear back on 3 other possible locations as I write this, so may have other options to tell you about.

Boundaries

I attended the American River Area's ad hoc committee on geographic boundaries as requested. We discussed the location of meetings connected with local ASCs (ours, American River's, Sierra Foothills), the boundaries suggested by our guidelines and by Sierra Foothill's guidelines, and the implications for services. It seemed logical to all in attendance that the American River would mark their Area's southern boundary, as suggested in our guidelines. Regarding Yolo County, it was suggested that AR specifically refer to Davis and West Sac, while we consider specifically naming Woodland to our guidelines.

November ASC SacFNA Vice-Chair Report

I facilitated our admin meeting in October. One of the items we discussed that I'm confident was covered in the report from the Chair is that this facility is closing for remodeling and what alternative locations we should be considering. We also discussed the work being done by the PR working group. One thing that came up was that a few months back the SacFNA ASC agreed that we should have liaisons going to the various American River subcommittee meetings so that we can be kept updated on issues arising there and keep communication channels open. I don't know who the liaison is to the American River Public Information Subcommittee, but I think we need to revisit the need for liaisons so that we can be informed about what, if anything is occurring in these subcommittees that we need to be aware of. I am unable to be a liaison to PI as I have an outside commitment on Thursday evenings.

Our PR Working Group had its first meeting on Tuesday October 9th. Five other individuals as well as myself attended. We discussed guidelines for PR from the NA PR Handbook, reviewed the three tasks we were asked to fulfill and discussed how to best accomplish these tasks. There's a lot of information gathering necessary, and we all chose different parts of the Sacramento area to focus our efforts on, so one person was going to collect information of possible locations for placing posters in downtown, another in the Rancho area, another in West Sacramento etc.. We're not going to contact these locations until we're ready to place the posters. I created an example of a poster using the examples in the NA PR Handbook as a guide. This is included in my report.

One of the things that the PR Handbook discusses is to be prepared for an increase in the number of calls coming into the phone line and an increase in the number of newcomers attending NA meetings. The impact on the phone lines is a concern. I attended the American River PI Subcommittee meeting so I could inform them of our activities and to talk with their phone line coordinator.

Most of the individuals at the meeting were supportive and encouraging as to our efforts. I was assured by their phone line coordinator that their phone line shifts are all covered and she will convey to the volunteers that this activity is forthcoming and to be prepared for an increase in calls. Currently the phone line is using approximately 1,200 of their 2,000 minutes a month. It was suggested that instead of placing posters in all the areas around Sacramento, that we target one area and see what the impact is. I discussed this with the other members of the Working Group, and we all agree that this is a good idea. Though we would love for addicts to start calling the phone line seeking help for their addiction, we don't want to overwhelm the volunteers or to suddenly use more than their allotted minutes and get a huge phone bill. If we put posters up in one area, and see what the impact is, we will be able to either continue targeting the same types of places, or modify our efforts if we're not finding a significant increase in calls to the phone line. Also, if calls do increase, American River can take steps to increase their allotted monthly minutes so they avoid overcharges.

The next meeting of the Working Group is scheduled for Tuesday November 13 at 7pm at Trinity Church in one of the classrooms on the first floor. We could use more help. We will discuss the results of our information gathering efforts and decide what part of Sacramento we want to target first. You should still have posters that were handed out at the ASC last month. If not, we have a few more available for you to take to your meetings.

I think we're going to have a lot of fun with this, and have a positive impact not only on the still suffering addicts who may find out that there is an alternative, but I think the phone line volunteers will also be energized by getting more calls (hopefully) from people seeking information about Narcotics Anonymous. And I know from talking with the members of the Working Group, that they are also enthusiastic about what they're doing and the sense of giving back to this program.

RCM Report

November 2007 ASC

I attended Region and we did do area reports. I did not attend Admin because I was on a business trip. The following is the report from the October RSC.

CAR (Conference Agenda Report) Assemblies

We still do not know if our area has been chosen to host the assembly. The RSC guidelines call for 5 CAR Workshops to be held between December 2007 and April 5, 2008. I will keep you updated.

RSC Inventory Update

We continued to follow up on our Regional Inventory and items that we want to change. We have decided to move forward with a pure model of Consensus Based Decision Making-No Robert's Rules. Region will request our area Chair to walk us through a training session and the Administrative Committee will create a model for RSC approval.

We also decided to rotate the RSC twice a year regularly as a matter of policy. Additional request will be considered by a case by case basis. We agreed to rotate once in the winter and once in the summer months. Picking and alternating odd/even month for each to allow both PR and H&I to experience one traveling RSC. We also agreed to hold small group discussion sessions quarterly and to coincide two of these with the traveling RSC's to maximize local fellowship participation.

(The information below has been copied and pasted from our RD's report)

World Service Board IP's

Based on Fellowship concerns over language in the World Board Approved Service IP "*An Introduction to Narcotics Anonymous Meetings*," the Pamphlet is being pulled from further distribution at this time. The concern was specific to the glossary of "Helpful NA Terms" that defined "Clean" as "*Abstinent from drugs (not including prescription medication)*." Obviously there was a strong reaction from the fellowship at this new definition of the term "clean."

There has also been some concern over the "Drug Replacement" section in the World Board IP "*NA Groups and Medication*." This IP takes a considerably different approach to NA members on drug replacement therapies than the previous World Services Bulletin #29 did. As part of my written feedback to the Board on the interaction with treatment/medical professionals at WCNA 32, I asked for some clarification on the decision to go a different direction with this piece, and have been assured that correspondence will occur after the next Board meeting.

As we reported previously, the board is developing three additional pieces; "*Leadership*," "*What is NAWS?*" and "*The Benefits of Service*." However, I'm sure the Board will hold some extended discussion about releasing these pieces without some form of RD feedback or further discussion on the nature of the authority given them at the 2006 WSC, given the reaction to the first set of IPs.

Bahrain Middle Eastern Zonal Workshop:

NAWS assisted in facilitating the second Middle Eastern Zonal gathering in May 2007. The first was held in 2005 in and this one again occurred in Bahrain as it is the one country without travel restrictions to either the Iranians or the Egyptians. Approximately 106 registered participants were on hand, including six women. Members present were from Bahrain, Egypt, Saudi Arabia, Jordan, Kuwait, Iran, United Arab Emirates, Qatar, Oman, and Turkey. All workshops were tri-lingual (English, Arabic, and Farsi). Workshops were on the Group Worksheet, service structure, sponsorship, public relations, traditions, and use of the Area Planning Tool. Members of the zone are discussing hosting a Middle East convention and regular newsletter.

The NAWS travel team was also able to attend a meeting in a correctional institution in which the Warden is a staunch advocate of NA. In fact, the warden has the daily “*Just for Today*” Meditation read over the prison PA system every morning!

Kuwait:

Part of the summer’s Middle East trip included NAWS first-ever visit to Kuwait. There are three groups in Kuwait, each speaking a different language (English, Arabic, and Farsi). The workshop centered on helping them develop a unified meeting schedule, discussion of sponsorship and building strong home groups. The sensitive subject of women’s attendance at the Arabic-speaking meetings was also raised.

Egypt:

On another leg of the Middle-East fellowship development trip, NAWS held a three-day workshop in Cairo with up to 179 Egyptian NA members in attendance (We don’t get that many to service workshops here in California)! Discussion topics were the usual: Sponsorship, service structure, treatment centers, events, and unity issues.

NAWS Public Relations:

As we’ve reported to you earlier, NAWS Board members and staff cannot keep up with the huge number of Public Relations events and opportunities world wide and have therefore adopted a new strategy of partnering with local communities to cover large events. The strategy is essentially that NAWS will use the organizations clout and resources to get us registered at large Conferences and then turn the actual presentation and staffing at these events over to experienced members of the local community. This summer, the strategy was used to allow members from Iran and the EDM to staff a professional conference in Istanbul, Turkey. Members from Hungary and Poland assisted the Slovenians in staffing a conference, conducting a presentation, and holding an open meeting in Slovenia.”

WORLD BOARD NEWS-

We have been asked by the Board of Directors to announce at our areas that there are 2 seats available on the Board. They have been taking on extra work because the seats are not filled.
